
Cohesion policy: why?

- Treaty (TFEU), art.174: "... to promote its overall harmonious development, ... leading to the strengthening of its economic, social and territorial cohesion
- Excessive disparities endanger the internal stability, the internal market, monetary union, and the credibility of the integration process itself
- Every union needs a stabilisation mechanism

Cohesion policy: how?

- Multi-annual programming
- Shared management partnership
- "Horizontal multi-level governance"
- Not a subsidy, but joint investment
- EU money as vehicle for better policy cycle





Reform of cohesion policy

- Key improvements needed:
 - Better management systems, governance
 - > Thematic concentration focus on key needs
 - Result orientation what change?
- Two goals:
 - Investment for growth & jobs
 - European Territorial Cooperation





Legislative package

- Common provisions regulation
- Fund specific regulations ERDF, ESF, CF
- ETC regulation
- EGTC regulation





Rules 2014-2020: main points

- Thematic concentration: max 4 TOs (ETC 80%)
- Cooperation: preparation + implementation+ financing or staffing
- Simplifications: incl. lump sum < 100,000 €
- Instruments ITI, CLDD, JAP





2. European Territorial Cooperation


- Art.174: "Among the regions concerned, particular attention shall be paid to rural areas, areas affected by industrial transition, and regions which suffer from severe and permanent natural or demographic handicaps such as the northernmost regions with very low population density and island, cross-border and mountain regions.
- Cross-border regions: just another handicap ?
- Eliminating the detrimental impact of borders is the essence of EU integration





ETC is about ...

- Partnership trust transparency
- Long-term, stages, maturity
- People, not countries
- Good for all, but does not come naturally > some help needed
- Something special ...





3: CBC Germany - Poland

- **2007-2013**
 - ➤ 3 programmes
 - Not easy (geography, partnership)
 - ➤ Not fast (absorption, decommitments?)
- **2014-2020**
 - ➤ Working basis: continue with 3, but ...
 - > EC: reflect on common approach / merge ?
 - Possible structure like DE-NL?





- Symmetry
- Central level
- Money
- Euroregions





Joint approach because ...

- ➤ Administrative borders ≠ reality, needs
- Single management structure, subsidiarity
- Common procedures, rules, criteria, control
- Strategic context, flagships
- A political signal





Common structure can work if

- ✓ Core needs of each partner are met
- √ Strategy differentiated
- ✓ Decentralised project selection
- ✓ Assurances on shares in funding





The process ...

- EC draft list of programme areas
 - consultation MS expert group
- Council, EP to agree on budget & rules
- Commission adopts regulations
- > Acts on funding, geography, etc.
- ➤ Draft programmes March 2014 ?
- > Adoption of programmes, start < end 2014
